The Trinidad and Tobago Creative Industries Company Limited (CreativeTT) is a wholly owned state enterprise that was incorporated on July 29, 2013. CreativeTT was established by The Government of the Republic of Trinidad and Tobago through the Ministry of Trade and Industry. It is mandated to stimulate and facilitate the business development and export activities of the creative industries in Trinidad and Tobago to generate national wealth. It seeks to achieve this mandate via its wholly owned subsidiary companies: Trinidad and Tobago Film Company Limited (FilmTT); Trinidad and Tobago Music Company Limited (MusicTT); and Trinidad and Tobago Fashion Company Limited (FashionTT).

CreativeTT, provides administrative and support services for all its subsidiaries companies. It is also responsible for their strategic and business development, including research and marketing; information technology; legal; finance and human resources. The subsidiaries would champion the development and commercialization of the local creative and cultural product in a sustainable manner.
